TERMS AND CONDITIONS

- 1. Old Harbour Dive Centre is run and controlled by Shotline Charters Ltd who have the control of all things related to the club including and not limited to member benefits, discounts, events and boat operations

- 3. All discounts and club benefits are for use by the club member only and will be monitored on the individual's member's profile

- 10. Every year, each member who does not have a diving medical signed by a physician, must complete a medical self-declaration to be held by Old Harbour Dive Centre. If a medical is required by the diver, a copy must be held by Old Harbour Dive Centre before any diving is allowed
- 11. I understand and agree that membership is yearly and runs from the 1st of May to the last day of April. I also understand that if I join at any time other than the 1st of May that I must pay the relevant fees up to the end of April, then from the 1st of May thereafter.
